

## THE STATEMENT OF COMPLIANCE FOR FOOD CONTACT

### To whom it may concerns

For the object of this document, see the following attachment.

Herewith we confirm that the above mentioned ziplock bags provided to SIAM by Yantai Bagmart Packaging Co., Ltd. **do comply with** Regulation 1935/2004/EEC and COMMISSION REGULATION (EU) No 10/2011, relating to plastic materials and articles intended to come into contact with food and **its all amendments**.

The monomers and additives used comply with the union list of authorized in Commission Regulation (EU) No 10/2011 on plastic materials and articles intended to come into contact with food .

The monomers used do not subject to any restriction.

The slip and anti-block additives used do not subject to any restriction. No dual additive is used.

In accordance to Commission Regulation (EU) No 10/2011, the total migration of the above mentioned products **did not exceed** 10 mg/dm<sup>2</sup> under the following test conditions:

- contact time: 240 hours. - contact temperature: 40 °C.
- food stimulants: A: 10% ethanol, B: 3% acetic acid and D<sub>2</sub>: olive oil or its substitutes :95% ethanol and isooctane.

The specific migration of heavy metal **do comply with** the requirements of the regulation (EU) No 10/2011.

The above mentioned products **do comply with** the guidelines for Good Manufacturing Practice as specified in Regulation (EC) No 2023/2006 (on good manufacturing practice for materials and articles intended to come in contact with food).

The types of food to be in contact with the above mentioned products are include: aqueous foods PH>4.5, acidic foods PH≤4.5, alcoholic foods, fatty foods.

Treatment- and storage conditions (time, temperature) during contact with foodstuff : t >24 hours, -20°C < T ≤40°C .
